Overview:

Over the month of July, we rolled out a number of enhancements to the user interface of the MedAdvisor for Pharmacy software designed to streamline everyday workflows.

What's New:

Ready to Collect Quick Action Button

- A Ready to Collect quick action Button has been added to medication orders in the MedAdvisor for Pharmacy Inbox (excludes pay in advance orders).
- Reduces steps required from pharmacists to fulfil medication orders.

Fosfomycin added to UTI Form

- The UTI Initial Service form now includes Fosfomycin as a treatment option.
- *Each state/territory has its own protocol. Pharmacists MUST check their authorisation to use Fosfomycin as a treatment option.*

- User interface of the MedAdvisor for Pharmacy Inbox has been updated to display SMS reply content from patients more clearly.
- This includes improvements to how it is displayed if multiple messages are received from the same patient.

You may have missed:

New Functionality in the Certificate for Leave Form

- **New email option:** Directly email a patient their Certificate of Leave at the conclusion of a service.
- **Automated digital signature:** Pharmacist signature loaded to the digital Certificate of Leave removing the need for printing and manual signatures.
- **Update patient data:** Demographic field editing now available for pharmacists to manually enter up-to-date data for patients not in dispense.


Additional Enhancements to AIR Integration:

- **Patient Immunisation History Statement:** Download a patient's immunisation statement from AIR directly within immunisation forms and email it upon request.
- **Expanded Patient Data Access:** View additional AIR details, including vaccine trial participation, natural immunity status, and upcoming National Immunisation Program (NIP) vaccines.
- **Improved Patient Search & Creation:** Search AIR for patient records and create new profiles in MedAdvisor without accessing dispense.

- Integrated two-way Secure Messaging offering pharmacies seamless communication with a patient's health care practitioner post consult.
